HOW TO MAKE A BOOKING?

The person who signs this contract must come himself and can not, for any reason rent his accommodation to someone else. The person must be an adult. The reservations can only be taken with this contract. You choose the accommodation type by crossing the right compartment. Then you send this contract back, filled in and signed, with the deposit and the registration fee. The registration fee can never be reimbursed, or be taken off your next stay. You will get a written confirmation of your booking which you will have to show on your arrival.

RENTAL ACCOMMODATION

In July and August a minimum of 7 nights is requested (arrivals between 4. p.m. and 8 p.m. / departures between 7.30 and 10:00 a.m.). The arrival days are Wednesdays, Saturdays or Sundays. Except on high season periods, the arrivals are possible on any days of the week. On arrival, you will receive the complete inventory of your accommodation. The sheets, pillow-cases, napery and towels are at your duty. The tenant has to control the inventory on arrival and tell the front desk at the latest the following morning if something wrong appears to him. A deposit of 300 € will be requested per credit card or cash money. An extra 300€ deposit is asked if the Mobile-Home has TV and 300 € for air conditioning. This deposit will be given back to the tenant after control of the accommodation on departure day, after eventual deduction for damage or inventory missing. The cleaning of the accommodation is the tenant's duty; an amount of 65 € to 75 € will be charged if we judge it not clean.

RENTAL CONDITIONS

All rentals are nominative and can in no way be sub-let; the signator of the contract must be over 18 years of age.

Accommodation

The tenant takes on the accommodation in the state that he finds it (trees, plants, vegetation...)

The campsite may not be held responsible in the event of damage due to the falling of branches, bad weather, natural disasters, theft with breaking and entering, broken windows...

The accommodation must be left at the end of the stay as it was found at the beginning.

The number of occupants in the holiday accommodation must not exceed the maximum authorised capacity (according to enclosed description).

Bookings

Booking fees will be charged for every booking.

No booking, from whatever category, becomes firm without our agreement and then only, upon receipt of contract, the deposit and the booking fees.

Any preferences stated at the time of booking will be satisfied when possible, without the campsite being held responsible.

The management reserves the right to refund clients should it be impossible to satisfy the demand.

Payment

Accommodation rental must be settled one month before arrival at the latest, without a reminder from ourselves.

If the payment is not received within these limits the rental will be cancelled according to the cancellation conditions noted below. The total amount of the rental is to be paid at once if the booking is made less than one month before the arrival date.

Departure and arrival hours

For accommodation rental, arrivals are from 4 p.m. onwards and departures up until 10 a.m. at the latest.

Should this not be respected, an extra day will be charged. No reduction will be made in the event of late arrival or premature departure.

In the lack of a written message (letter, fax, telegram) from the tenant stating that he had to delay his arrival, the accommodation becomes available 24 hours after the arrival date marked on the rental contract and the totality of the payment is still required. Telephone messages are not acceptable.

In the event of date's changes, the same residence cannot be guaranteed.

Cancellation

Any cancellation must be notified by registered mail.

In the event of a cancellation, the booking fee will be retained.

To compensate the breaking of the contract the following amounts will be retained, or will remain owing:

- 35 % of the total amount for all cancellations more than 30 days before the arrival date.
- The total amount must be paid for all cancellations less than 30 days before the arrival date, or if you fail to arrive on the set date.

We propose a cancellation insurance, which is 2.7% of the amount of your stay and has to be taken with your booking. Ask for the flyer "Camp-covered" while reservation is taken or download it from our website.

Insurance

Regular holidaymakers benefit from our Civil Liability cover for any physical injury or material damage encountered that is legally proved to be our responsibility. They must have their own valid insurance cover for their equipment (or rented equipment) which protects them as far as Civil Responsibility is concerned.

Miscellaneous

The management reserves the right to refuse a rental and to evict anyone who causes a disturbance and if necessary, to change any facility or service noted in the brochure.

The Court of Draguignan is the court of competent jurisdiction. Only French law is valid.
