CAMPING REGULATION

The stay in the campsite is calculated from whatever time on the day of arrival to 10:00 a.m. on the day of departure. Should the stay extend beyond that time (10:00 a.m.), an extra day will be charged. * The fee "big tent pitch" will be charged each time a tent of more than 2 places will be installed, regardless of the actual number of occupants. Two tents cannot be installed on the same pitch. Each tent installed will be charged the relevant occupied pitch. One or more tents in the caravan/camper pitch cannot be installed. Each tent installed will be charged the relevant occupied pitch.

The Caravan-Camper van rate includes one veranda, which must be connected to the vehicle. Any vehicle used for sleeping is considered a camper van (car, SUV, etc.). In certain periods of the season (e.g. in mid-August), a minimum period of stay may apply. Bookings by groups of minors (with no accompanying adult) shall not be accepted. **Beach service available from July upon renewal of the annual concession.**

SERVICES INCLUDED IN THE PRICE

Guest reception service with reception open 24 hours a day, external surveillance service, a car/motorbike parking space (each additional parking space with a surcharge. For further details, see camping village fee). The camping is equipped with two groups of services powered by solar energy, with free warm water for the personal hygiene.

Swimming pool service including sun loungers, 2 Jacuzzis, 2 children s' play area, the use of the tennis court and the Ping-Pong table. Water Fitness: from 01st/07 to 10th/09 at least 5 evenings per week. Mini-club (3 years of age) – Evening musical entertainment: from 15/06 to 15/09 at least 3 evenings per week.

COMPULSORY VISITOR'S TAX PURSUANT TO ARTICLE 4 OF ITALIAN LEGISLATIVE DECREE NO. 23 OF 14/03/2011

€ 0.50 city tax per person per night to article 4 of Italian Legislative Decree No.23 of 14/03/2011, for all non-hotel accommodation facilities (max for 7 consecutive nights). The visitor's tax applies to campsites and is compulsory for all tourists. It has to be paid for every overnight stay in the Municipality of Alghero and is not subject to reductions or special offers. The charges, which are collected by the camping village, are passed to the Municipality of Alghero. The tax is not applicable to minors under the age of 12.
