

General terms and conditions (GTC)  
of Ostseestrand Campingplatz Scharbeutz GmbH

**§ 1 Contract**

Information given and other assurances are tentative and the contract is only binding if we confirm in writing.

**§ 2 Deposit**

1. At the time of booking you have to pay a deposit of 40 % of the total amount. This has to be paid till 21 days before your arrival.

2. We ask you to keep the payment conditions in mind. Should the payment be delayed by more than 7 days we may make use of the termination without notice.

**§ 3 Additional Costs**

Please balance your additional costs e.g. electricity at the day of departure at our reception.

**§ 4 Cancellation and reduction**

1. Including the day of your arrival 6 pm, you may cancel your reservation in writing without giving reasons.
2. In case of cancellation you have to make a compensation payment:
  - a. 28 till 22 days to your arrival: 20 % of the regular price
  - b. 21 till 15 days to your arrival: 40 % of the regular price
  - c. 14 till day to your arrival: 60 % of the regular price
  - d. 7 till 2 day to your arrival: 80 % of the regular price
  - e. as from 2 days to your arrival: 100 % of the regular price
3. We do not pay compensation if you depart earlier then contracted. You have the opportunity to get a voucher of the amount left. This voucher you can use for your next reservation within the same year.

4. Should your pitch be not engaged by yourself within one day after your contracted arrival 11 am, we have the right to give it to another guest. This also applies if you depart earlier.

**§ 5 Campsite Rules and householder's rights**

1. You and your fellow travellers have to obey the campsite rules.
2. If there is a gross violation we may make use of the termination without notice.

**§ 6 Liability**

1. We please you to treat all items and your pitch with respect. If there are any lacks you caused you have to refund expenses.
2. We are not liable for your property or any lacks caused by the act of nature.

**§ 7 Fallacy**

We have the right to correct fallacies and errors in printing or calculation.

**§ 8 Severability**

If any paragraph of our GTCs gets inoperative they apply by analogy. The other phrases remain in force.

**§ 9 Place of jurisdiction**

The place of jurisdiction is Scharbeutz.
